After the reading of the Open Public Meeting Act, the regular monthly meeting of the Board of Fire Commissioners, Fire District #2, Township of Aberdeen was called to order on Monday, July 2, 2018 at 8:00PM in the Cliffwood Fire House.

The minutes of the previous regular meeting of June 4, 2018 were passed out to all Commissioners and the public. Additions, corrections and/ or deletions will be addressed at the end of the meeting.

<u>Building and Grounds</u> – Comm. Bellamy states, the Soffet is coming loose from the building. The construction company has been called. The room for the tables and chairs need to be painted, also wanted to know if the Commissioners could oversee the tables and chairs. Since the Fire company owns them, things will remain as is. Air Exhaust Systems will not start their work until August.

<u>Truck, Radios and Equipment-</u>Comm. DeGiglio reports, 491's check engine light is on. Blaze will be coming. Need to order equipment from New Jersey Fire Equipment. Total is \$4205.60. Comm. Black makes a motion, Comm. Bellamy seconds it. Estimate for 5" pipeline is \$4,600. Commissioners want to put off till end of the year. Chief's truck repair will cost \$6,271.89. We will not be repairing it. Fire Official offered his vehicle on the weekends to the Chief.

<u>Training grounds</u> – Comm. Bellamy reports, a fence with a lock will be put up. An ATV is stored in the trailer and needs to be removed. Comm. DeGiglio say's clean up is needed.
